



On-licence

Sections 14 and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012, **Wild Earth Wines Limited** is authorised to sell and supply alcohol on the premises situated at 180 SH8B and known as The Stoaker Room, to any person for consumption on the premises and to let people consume alcohol there. 67/ON/7/2019

Endorsement

Section 38 of the Act applies to this licence and the licensee is authorised to deliver alcohol from the premises and sell it on any other premises for consumption on those other premises by people attending a reception, function or social gathering promoted by a person or association of people other than the licensee.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart of Part 2 of the Act.

Conditions

This licence is subject to the following conditions:

- a) No alcohol is to be sold on Good Friday, Easter Sunday, Christmas Day or before 1.00pm on Anzac Day to any person who is not present on the premises for the purpose of dining.
- b) Alcohol may be sold only on the following days and during the following hours:
Monday to Sunday 9.00am to midnight to any person who is present on the premises
- c) The following steps must be taken to promote the responsible consumption of alcohol;
 - (i) A range of food choices must be readily available at all times that the premises are open. Menus must be visible and food should be actively promoted.
 - (ii) The licensee must ensure that signs are prominently displayed within the licensed premises detailing information regarding alternative forms of transport from the premises.
 - (iii) The licensee must implement and maintain the steps proposed in the application for the licence aimed at promoting the responsible consumption of alcohol.
 - (iv) At all times there must be a reasonable range of non-alcoholic refreshments, free drinking water and low-alcohol beverages available.
- d) Each of the following parts of the premises is designated as a supervised area: Bar Area
- e) The licensee must ensure that the provisions of the Act relating to the sale supply and consumption of alcohol to prohibited persons are observed and must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.
- f) A copy of this licence must be displayed at the principal entrance to the premises.

Duration

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force—

- (a) Until the close of the period of 1 year commencing with the date of its issue.
- (b) If an application for the renewal of the licence is duly made, until the application is determined; or
- (c) If the licence is renewed, until the close of the period for which it is renewed.

Expiry date being **13 March 2020** unless renewed for a further period.

Off-licence

Sections 17 to 20 and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012, **Wild Earth Wines Limited** is authorised to sell alcohol on the premises situated at 180 SH8B and known as the The Stoaker Room, to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises. 67/OFF/8/2019

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

Conditions

This licence is subject to the following conditions:

- a) No alcohol is to be sold or delivered on Good Friday, Easter Sunday, Christmas Day or before 1.00pm on Anzac Day.
- b) Alcohol may be sold or delivered only on the following days and during the following hours:
Monday to Sunday 9.00am to 10.00pm
- c) Alcohol may only be delivered Monday to Sunday between the hours of 6.00am and 11.00pm.
- d) Each of the following parts of the premises is designated as a Supervised area: Bar Area
- e) The licensee must ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed and must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.
- f) A copy of this licence must be displayed at the principal entrance to the premises.

Duration

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force-

- a) Until the close of the period of 1 year commencing with the date of its issue; or
- b) If an application for the renewal of the licence is duly made, until the application is determined; or
- c) If the licence is renewed, until the close of the period for which it is determined.
